1. Employers are required by law to withhold a certain amount of your pay for federal income tax (FIT). The Internal Revenue Service provides employers with tables that show how much money to withhold. The amount withheld depends on your income and withholding allowances. You may claim 1 allowance for yourself and 1 for your spouse if you are married. You may claim additional allowances for any others you support. Below is a withholding allowance table from the IRS.
